Statement:

The Kansas City Missouri Police Department (KCPD) has failed to control violent crime in the city, and the KCPD has unconscionably discriminated against Black American citizens of Kansas City. The Social Justice Ministry (SJM) of St. Mary's Episcopal Church of Kansas City Missouri demands changes in the KCPD to eliminate the systemic racism and failed policing policies in the KCPD that are major causes of excessive crime and racial discrimination in Kansas City. Those changes mean that the KCPD will be fundamentally transformed and recreated but not defunded.

Because of the violence and discrimination against them, Black Americans best understand the problems and how they can be eliminated. They need to be leaders of the efforts to overhaul the KCPD. White people must support and join them but not act like they know best.

First, Chief Rick Smith must resign or be fired because of his failure to provide leadership during the protests. He continues to condone the use of excess force by his officers. He seemingly does not understand the effects of years of violence by the KCPD against Blacks. He has failed to show empathy for the protesters. Additionally, Smith has been too protective of officers who have killed or injured Black Americans.

The policies and procedures of the KCPD, and indeed its institutional culture, must be significantly reformed and recreated. It is not a question of making some reforms around the edges.

In fact, the efforts at reform made after Rodney King's beating, the efforts after the killing of Michael Brown in Ferguson, MO, and efforts in other cities have failed to reduce police violence against Black Americans. Kansas City is still confronted with too many killings, injuries, and too much discrimination by the police.

Body cameras and diversity training are helpful but do not get to the root causes of police violence against Black Americans. Fundamental change is the only answer.

The Kansas City Star (06/02/20) made several good suggestions for fundamental changes for the KCPD. These included three the SJM believes KC Blacks and other citizens support and will produce visible, beneficial results:

Create a citizens' review board. The board will handle complaints against
officers. The board must be independent and not controlled by the Board of
Police Commissioners, the City Council, the KCPD, or prosecutors. The review
board should have its own staff, legal assistance, open hearings, subpoena
power, access to all needed records, and the power to dismiss or impose other

penalties on officers who use excessive force or discriminate against Black Americans or any others.

- Demilitarize the police. The KCPD has obtained and used too much military
 equipment that makes it look and act like an occupying army and not a protective
 police force. This creates distrust in the police. There was absolutely no reason
 for KC police to be dressed in full military riot gear when they confronted and
 attacked peaceful and helpless persons protesting about the murder of George
 Floyd by Minneapolis police. The KCPD must be demilitarized
- Institute local control. The present system of control of the KCPD by the Board of Police Commissioners and not the City Council deprives KC citizens of control of the police. Local control makes the KCPD more accountable. The City Council, the existing Board of Police Commissioners, and all of KC must get the legislature to give control to the City Council.

More generally, there are other principles and policies for achieving fundamental transformation of the KCPD that should be adopted by the KC City Council or the Board of Police Commissioners:

- Reduce police contact with the public. The present system gives the police the power and opportunity to harass and kill with impunity.
- Police officers should not respond to certain kinds of emergencies and problems

 domestic violence, drug use and related crimes, homelessness, mental and
 physical health emergencies, minor traffic offenses. Leave those problems to
 social workers, health care professionals, and other agencies. Police are not
 adequately trained or needed to deal with these problems.
- Funding of the KCPD must be substantially reduced. The KCPD has a budget of \$273 Million or \$554 for each citizen of KC. The KCPD spends four times as much per person as Omaha, a city comparable to KC, spends on its police department. It spends twice as much as Overland Park spends per capita for its department. (KC Star 06/14/20). Obviously, KC is over-policed, and millions can be cut from the budget. Use those huge savings for public housing, education, medical and mental health care, and job security to begin to deal with the root causes of the huge inequalities and violent crime in KC.

<u>Title:</u> Kansas City Police Violence Against Constitutional Non-Violent Civil Disobedience

Statement:

The Social Justice Ministry (SJM) of St. Mary's Episcopal Church of Kansas City, Missouri, supports the non-violent protesters in Kansas City, Portland, Kenosha, Minneapolis, and elsewhere who are protesting about the unconscionable murders and shootings by police of Black persons.

Those murders and shootings are another horrendous example of decades of police brutality and discrimination against Black Americans. Too many Black Americans in Kansas City have been innocent victims of such brutality and unconstitutional acts of violence by the police.

Based on their past acts of violence against Black Americans, it is no surprise that KC police failed miserably in how they handled the protests about the murder of George Floyd.

There was a failure of leadership when Chief Rick Smith had no comment on the officer who killed George Floyd. For two days, he said nothing about protests in Kansas City. Instead the Chief sent a public relations officer out to speak. (Melinda Henneberger, KC Star 6/2/20). Police fired tear gas, rubber bullets, and pepper spray at non-violent protesters exercising their constitutional right to protest and declared unnecessary assemblies as a pretext to use force. At one point, they incorrectly tried to blame the violence on non-resident agitators. (KC Star 6/3/20).

Non-violent acts of civil disobedience are a necessary response to the systemic racism in the KCPD and our city. Such protests will be disruptive, but must be allowed in order for Black Americans to obtain their basic rights that have been cruelly denied for far too long. If there are persons destroying property or attacking others, the police can deal with them, but at the same time police must not disrupt or attack the non-violent protesters exercising their First Amendment rights. Unfortunately, the police have not been trained how to protect the good and arrest the bad.

White people will bear most of the costs and inconveniences of non-violent civil disobedience; however, it was white people who created the system that caused Black Americans to be murdered, injured, and discriminated against.

Under these conditions, the basic rights lost by Black Americans are of far greater value than the costs for white people caused by the acts of non-violent civil disobedience; therefore, the greatest good-for-all causes costs of the non-violent acts of civil disobedience to be borne by the creators of the system.

St. Mary's Social Justice Ministry, Statement 11/29/20:

Confronting the police, ignoring a curfew time, blocking and marching in a street or sidewalk, blocking a police car, or blocking a business or a governmental facility entrance are examples of non-violent acts of civil disobedience that must be considered non-criminal and constitutionally protected when done to obtain Black Americans' basic human rights. Police must not have the power to arrest, remove or intimidate protesters engaging in those non-violent actions.

Whites created a system designed to control and exclude Blacks. Then, with all the power, whites created a police force that protected whites' property interests. The result was a cruel and flawed policing system that is a major cause of our sad state of affairs. As stated above, whites must bear the cost of ridding our county of that blight.

Strikes, pickets, and refusals to work are other forms of non-violent civil disobedience that are very effective. A wise person said it best: the one thing they cannot do is make us work. To be successful, such non-violent civil disobedience by Black Americans and others to end police violence and discrimination against Blacks must be supported by and participated in by those with power and privilege (white people).

Non-violent civil disobedience does cause significant disruption; but with any great change, the pain and disruption will be rewarded with great gains.

It has come to my attention that the police contracts for the Kansas City Police Department are negotiated by the Kansas City Fraternal Order of Police, without public input, and that these contracts contain a number of policies that decrease transparency and accountability in our police department. I demand that you use the governing power of your respective bodies to immediately open these contract negotiations to the public. Good morning, I would like to thank Officer Marcus Nelson. I was doing my walk/run one evening and I wasn't properly hydrated. I was catching muscle cramps in both my legs and Officer Marcus Nelson saw from a distance that I was injured and immediately when I tried making it back to my apartment. He was able to assess my injuries and assisted by safely saying that I wasn't hydrated and that I needed potassium. He was correct. Embarrassed and all. He was like, Yeah, you might want to head back home and take care of that. I can't thank him enough because if I would have tried to continue that I'd be out for months and I refuse to give up on becoming 100% whole. I am a survivor of Domestic Violence and North Oak Crossings is my safe place. I was in an abusive marriage for 7 1/2 years. I am Native American and because of colorism, it is the perception that I'm "mental." I don't dwell there. I want to thank the entire staff, the legal team, everyone that works for the KCPD. Thank you! Because of you and because of my will to live, I never gave up. I was able to sneak out of my home after being beat and kept as a slave, an indentured servant. I am able to continue to do what I love which is walk and run. My ex husband moving me to District 1 and me keeping the abuse secret from my family because of pride and humiliation all at the same time still aren't aware and I don't care at this point how and what their opinion is of me. In sickness and in health, my ex husband was cruel and abusive in all manners. I am attending Harvard University, their extended learning classes to become a judge, this is my 3rd year. I am a computer aided drafter and I've completed the Building Information Modeling Class for Autodesk University.

Moving forward.

My goal is to shed a light on things like Police Brutality and I want the Police to understand that they do have rights! This last 2 instances, there is a singer on youtube, the songtress that has inmates from KCMO that raps a song that states to cause injury and to be really extra to gain money from the state/police. There are alot of laws that protects in regards to releasing media, which legally isn't allowed. All in all, it is about the Tier 1, 2, 3 and 4, the money that is allocated for the Police Department which isn't monopolized and that is why there are so many lawsuits against the police. That money when it isn't allocated, on the I-9 form, which goes to the retirement/pension plans just rolls over to the DOJ. The Union laws protects the police, individuals like Stacy Shaw, has misinterpreted the laws. I'm hoping that the police and the commissioner and their legal team fights back and holds court in judges chambers because they do not have to step down when they are the victims, (the Police Officers) all that is legally required is additional training. <u>Title:</u> Kansas City Police Violence Against Constitutional Non-Violent Civil Disobedience.

Statement:

The Social Justice Ministry (SJM) of St. Mary's Episcopal Church of Kansas City, Missouri, supports the non-violent protesters in Kansas City, Portland, Kenosha, Minneapolis, and elsewhere who are protesting about the unconscionable murders and shootings by police of Black persons.

Those murders and shootings are another horrendous example of decades of police brutality and discrimination against Black Americans. Too many Black Americans in Kansas City have been innocent victims of such brutality and unconstitutional acts of violence by the police.

Based on their past acts of violence against Black Americans, it is no surprise that KC police failed miserably in how they handled the protests about the murder of George Floyd.

There was a failure of leadership when Chief Rick Smith had no comment on the officer who killed George Floyd. For two days, he said nothing about protests in Kansas City. Instead the Chief sent a public relations officer out to speak. (Melinda Henneberger, KC Star 6/2/20). Police fired tear gas, rubber bullets, and pepper spray at non-violent protesters exercising their constitutional right to protest and declared unnecessary assemblies as a pretext to use force. At one point, they incorrectly tried to blame the violence on non-resident agitators. (KC Star 6/3/20).

Non-violent acts of civil disobedience are a necessary response to the systemic racism in the KCPD and our city. Such protests will be disruptive, but must be allowed in order for Black Americans to obtain their basic rights that have been cruelly denied for far too long. If there are persons destroying property or attacking others, the police can deal with them, but at the same time police must not disrupt or attack the non-violent protesters exercising their First Amendment rights. Unfortunately, the police have not been trained how to protect the good and arrest the bad.

White people will bear most of the costs and inconveniences of non-violent civil disobedience; however, it was white people who created the system that caused Black Americans to be murdered, injured, and discriminated against.

Under these conditions, the basic rights lost by Black Americans are of far greater value than the costs for white people caused by the acts of non-violent civil disobedience; therefore, the greatest good-for-all causes costs of the non-violent acts of civil disobedience to be borne by the creators of the system.

St. Mary's Social Justice Ministry, Statement 10/28/20:

Confronting the police, ignoring a curfew time, blocking and marching in a street or sidewalk, blocking a police car, or blocking a business or a governmental facility entrance are examples of non-violent acts of civil disobedience that must be considered non-criminal and constitutionally protected when done to obtain Black Americans' basic human rights. Police must not have the power to arrest, remove or intimidate protesters engaging in those non-violent actions.

Whites created a system designed to control and exclude Blacks. Then, with all the power, whites created a police force that protected whites' property interests. The result was a cruel and flawed policing system that is a major cause of our sad state of affairs. As stated above, whites must bear the cost of ridding our county of that blight.

Strikes, pickets, and refusals to work are other forms of non-violent civil disobedience that are very effective. A wise person said it best: the one thing they cannot do is make us work. To be successful, such non-violent civil disobedience by Black Americans and others to end police violence and discrimination against Blacks must be supported by and participated in by those with power and privilege (white people).

Non-violent civil disobedience does cause significant disruption; but with any great change, the pain and disruption will be rewarded with great gains.

Statement:

The Kansas City Missouri Police Department (KCPD) has failed to control violent crime in the city, and the KCPD has unconscionably discriminated against Black American citizens of Kansas City. The Social Justice Ministry (SJM) of St. Mary's Episcopal Church of Kansas City Missouri demands changes in the KCPD to eliminate the systemic racism and failed policing policies in the KCPD that are major causes of excessive crime and racial discrimination in Kansas City. Those changes mean that the KCPD will be fundamentally transformed and recreated but not defunded.

Because of the violence and discrimination against them, Black Americans best understand the problems and how they can be eliminated. They need to be leaders of the efforts to overhaul the KCPD. White people must support and join them but not act like they know best.

First, Chief Rick Smith must resign or be fired because of his failure to provide leadership during the protests. He continues to condone the use of excess force by his officers. He seemingly does not understand the effects of years of violence by the KCPD against Biacks. He has failed to show empathy for the protesters. Additionally, Smith has been too protective of officers who have killed or injured Black Americans.

The policies and procedures of the KCPD, and indeed its institutional culture, must be significantly reformed and recreated. It is not a question of making some reforms around the edges.

In fact, the efforts at reform made after Rodney King's beating, the efforts after the killing of Michael Brown in Ferguson, MO, and efforts in other cities have failed to reduce police violence against Black Americans. Kansas City is still confronted with too many killings, injuries, and too much discrimination by the police.

Body cameras and diversity training are helpful but do not get to the root causes of police violence against Black Americans. Fundamental change is the only answer.

The Kansas City Star (06/02/20) made several good suggestions for fundamental changes for the KCPD. These included three the SJM believes KC Blacks and other citizens support and will produce visible, beneficial results:

Create a citizens' review board. The board will handle complaints against
officers. The board must be independent and not controlled by the Board of
Police Commissioners, the City Council, the KCPD, or prosecutors. The review
board should have its own staff, legal assistance, open hearings, subpoena
power, access to all needed records, and the power to dismiss or impose other

penalties on officers who use excessive force or discriminate against Black Americans or any others.

- Demilitarize the police. The KCPD has obtained and used too much military
 equipment that makes it look and act like an occupying army and not a protective
 police force. This creates distrust in the police. There was absolutely no reason
 for KC police to be dressed in full military riot gear when they confronted and
 attacked peaceful and helpless persons protesting about the murder of George
 Floyd by Minneapolis police. The KCPD must be demilitarized
- Institute local control. The present system of control of the KCPD by the Board of Police Commissioners and not the City Council deprives KC citizens of control of the police. Local control makes the KCPD more accountable. The City Council, the existing Board of Police Commissioners, and all of KC must get the legislature to give control to the City Council.

More generally, there are other principles and policies for achieving fundamental transformation of the KCPD that should be adopted by the KC City Council or the Board of Police Commissioners:

- Reduce police contact with the public. The present system gives the police the power and opportunity to harass and kill with impunity.
- Police officers should not respond to certain kinds of emergencies and problems

 domestic violence, drug use and related crimes, homelessness, mental and
 physical health emergencies, minor traffic offenses. Leave those problems to
 social workers, health care professionals, and other agencies. Police are not
 adequately trained or needed to deal with these problems.
- Funding of the KCPD must be substantially reduced. The KCPD has a budget of \$273 Million or \$554 for each citizen of KC. The KCPD spends four times as much per person as Omaha, a city comparable to KC, spends on its police department. It spends twice as much as Overland Park spends per capita for its department. (KC Star 06/14/20). Obviously, KC is over-policed, and millions can be cut from the budget. Use those huge savings for public housing, education, medical and mental health care, and job security to begin to deal with the root causes of the huge inequalities and violent crime in KC.


